The Tecate Community Sponsor Group has requested that the County investigate the feasibility of a colonia designation and its potential to work concurrently with the GP2020 process to help determine potential land use options for the Tecate area.

BACKGROUND:

Tecate, California is a border community located in southeastern San Diego County approximately 40 miles east of the city of San Diego. While the current population is approximately 200, the town's location directly adjacent to an urban core of about 100,000 people in the city of Tecate, Mexico creates an urban situation unique from that of surrounding communities.
